Agency scientists are monitoring large databases containing medical information on millions of Americans for patterns that might suggest a hitherto unknown side effect of vaccination, said Dr. Demetre Daskalakis, director of the C.D.C.'s National Center for Immunization and Respiratory Diseases.

“We toe the line by reporting the signals that we think are real signals and reporting them as soon as we identify them as signals,” he said. The agency’s systems for monitoring vaccine safety are “pretty close” to ideal, he said.













Primary Results: Among 3,962 patients treated for mild COVID-19, prior to the development of moderate or severe levels of disease stage, none died as compared to 3.03% (2.25% risk adjusted) (OR = 0.0000, $p < 0.0001$) in the same county and time period. Of those 3,962 patients, 0.05% were hospitalized as compared to 22.68% (20.76% risk adjusted) (OR = 0.0019, $p < 0.0001$) in the same county and time period. Differences in outcomes among All Valley Urgent Care patients based on the severity at the time of presentation were observed. Those patients receiving treatment while presenting mild COVID-19 were less often hospitalized (OR = 0.0293, $p < 0.0001$) and suffered lower mortality (OR = 0.0000, $p = 0.0008$). Results suggest a highly significant impact for these multidrug protocols. No serious side effects, including cardiac side effects, were observed.

They wrote up their results and submitted it to peer-reviewed journals, **but no one was willing to publish it.**

SUMMARY

Viruses that replicate in the human respiratory mucosa without infecting systemically, including influenza A, SARS-CoV-2, endemic coronaviruses, RSV, and many other “common cold” viruses, cause significant mortality and morbidity and are important public health concerns. Because these viruses generally do not elicit complete and durable protective immunity by themselves, they have not to date been effectively controlled by licensed or experimental vaccines. In this review, we examine challenges that have impeded development of effective mucosal respiratory vaccines, emphasizing that all of these viruses replicate extremely rapidly in the surface epithelium and are quickly transmitted to other hosts, within a narrow window of time before adaptive immune responses are fully marshaled. We discuss possible approaches to developing next-generation vaccines against these viruses, in consideration of several variables such as vaccine antigen configuration, dose and adjuvantation, route and timing of vaccination, vaccine boosting, adjunctive therapies, and options for public health vaccination policies.

- The Biden White House's Censorship Campaign Targeted True Information, Science, and Other Content that Did Not Violate the Platforms' Policies. Contrary to their claims of wanting to combat alleged so-called "misinformation" and foreign disinformation, the Biden Administration pressured the companies to censor true information, satire, memes, opinions, and Americans' personal experiences.
 - For example, internal July 2021 Facebook emails obtained by the Committee and Select Subcommittee show that Facebook understood that the Biden White House's position was wanting "negative information or opinions about the vaccine" removed as well as "humorous or satirical content that suggests the vaccine isn't safe."¹²
 - The same set of emails also noted that "The Surgeon General wants us to remove true information about side effects."¹³

In the weeks and months following the start of the White House pressure campaign, Facebook, YouTube, and Amazon all changed their content moderation policies. The White House pressured companies to censor information that did not violate their content moderation policies at the time. The best evidence to assess why content moderation policies were changed is to review relevant email correspondence and other documents at the time of the policy change. Indeed, both Facebook and Amazon referred to the Biden White House's efforts as "pressure." Here is a subset of key documents first obtained by the Committee and Select Subcommittee pursuant to subpoena:

- In March 2021, an Amazon employee emailed others within the company about the reasons for the Amazon bookstore's new content moderation policy change: "[T]he [reasons for this change] are criticism from the Biden Administration about sensitive books we're giving prominent placement to."
- In March 2021, just one day prior to a scheduled call with the White House, an Amazon employee explained how changes to Amazon's bookstore policies were being applied "due to criticism from the Biden people."
- In July 2021, when Facebook executive Nick Clegg asked a Facebook employee why the company censored the main-race theory of the SARS-CoV-2 virus, the employee "have to live with the [Biden] Administration." Facebook should try to think creatively about "how we can be responsive to [the Administration's] concerns."
- In April 2021, YouTube's Public Policy team emailed YouTube's Product team that having the Product team "help the Biden White House work to be 'highly beneficial' because the company can 'work and to work closely with [the Biden] administration on multiple policy issues.'"
- The Biden White House Pushed Censorship of Books, Not Just Social Media. The Biden White House pressure campaign was not limited to just social media companies, but also the world's biggest online bookstore, Amazon.¹⁴

The parallels for the three companies are striking. In each case, the companies identified the Biden White House's censorship requests as "pressure" or noted a fear that things could "spill" out of control.¹⁵ And while there is a difference in how long and in what ways each company succumbed to the White House's pressure, by September 2021, Facebook, YouTube, and Amazon had each adopted new content moderation policies that removed or reduced viewpoints and content disfavored by the Biden White House.¹⁶

The Facebook Files. In February 2021, Facebook increased its censorship of anti-





This study adds to a growing list of published peer-reviewed papers that compare the health of vaccinated children to the health of unvaccinated children. These studies suggest we have long underestimated the scope of vaccine harms, and that the epidemic of chronic illness in children is hardly a mystery.

Cumulative office visits in the vaccinated (orange) vs. unvaccinated (blue) patients born into the practice: the clarity of the age-specific differences in the health fates of individuals who are vaccinated (2763) compared to the 561 unvaccinated in patients born into the practice over ten years is most strikingly clear in this comparison of the cumulative numbers of diagnoses in the two patient groups. The number of office visits for the unvaccinated is adjusted by a sample size multiplier factor (4.9) to the expected value as if the number of unvaccinated in the study was the same as the number of vaccinated.





Figure 3. An increase in the toxicant exposures to the vitamin K shot with its adjuvant and the maternal vaccines with their cocktail of additional toxicants leads, unsurprisingly, to measurable increases in toxicity with each added toxicant of interest.







Figure 2. Simon-Makuch plot comparing the cumulative incidence of COVID-19 for subjects stratified by



Attach please find four tables with RRs and three SAS programs:

Sumstat_alldia_sort (created by TH_anal_nonbob_expl3.txt) has the RRs after PH models adjusted for gender, site and birthyear for all diagnoses included.

Sumstat_alldia_sort2 has the RR for the conditions that came out to be relevant from the first list.

Sumstat_alldia_strat (created by TH_anal_bob_str) has the same after stratification for site, year and month of birth, adjusting for gender and leaving out the kids that got HepB immunoglobulines. It differs very little from the previous, except for the coordination disorders.

Sumstat_bob (created by TH_anal_bob_expl3.txt) has the RRs for the categories of diagnoses, adjusted, not stratified (I did it for one and got basically the same result).

In the lists you'll also see the sample size for each category and the referent category, some of which are quite small when making 4 categories, reason for using 3 slightly different categories with similar results (Hg3cat1 vs. hg4cat1 and hg3cat3 vs. hg4cat3).

I added another exposure variable (addcat) in one list that looks at the increase of mercury each month for the first three months, divided by the average bodyweight in the first, second and third month and takes the maximum value of this. This does not show much, to which I would conclude that, except for epilepsy, all the harm is done in the first month.

As these neurologic developmental conditions are very much related (odds of having one when also having the other go from 20 to 100!), I added the first five (called mix) and checked what happened to the RRs. (You get some sort of average.) I will explore the possibility of some sort of factor analysis to replace the conditions by one variable.

As you'll see some of the RRs increase over the categories and I haven't yet found an alternative explanation.... Please let me know if you can think of one. Frank proposes we discuss this on a call after NewYear.

Also attached my EIS abstract to get your input.



My claim

Every single comparison of the fully vaxxed versus fully unvaxxed in the US that has ever been published in the peer reviewed literature with at least 250 in each cohort and comparing a wide range of health outcomes shows that the unvaxxed are healthier (e.g., fewer chronic diseases, fewer infections, fewer office visits needed).


The real story of polio



A note about scientific evidence

There are some people who demand RCTs to prove causality. These people are not scientists. Scientists consider all evidence and look to find **which hypothesis is the most likely to be correct.**

Evidence doesn't require a control group. For example if 100 kids gets the vax and 20 kids develop autism behaviors within 24 hours of the shots, this is statistically highly unlikely if the shots aren't causing the effect. That's "evidence."

Quite often, the anecdotal evidence that can be VERIFIED can provide stronger proof than double-blind randomized controlled trials. For example in DB RCTs, the investigators often claim that "none of the deaths were JUDGED to be caused by the vaccine." This is what they did in the Pfizer trial. It was done without evidence (such as the histopathology studies using the proper stains).

They claim our papers are wrong and theirs are right.

Glyphosate and autism: the link

People don't want to hear this, but it seems important, and maybe people are ready to hear it now in 2023: Glyphosate is in vaccines. It was found in vaccines in 2016, but has probably been in vaccines, in small but increasing amounts, since the late 1970s.

In 2016, the nonprofit Moms Across America sent five childhood vaccines to Microbe Inotech Laboratories to be tested for glyphosate. Using the ELISA test, glyphosate was found in all five vaccines, at 0.107 to 2.671 parts per billion. The MMR vaccine, which is grown as a live culture on gelatin, contained the most glyphosate. Additional tests from multiple labs on 19 vaccines confirmed the contamination; this was reported on in the peer-reviewed paper “Glyphosate pathways to modern diseases VI: Prions, amyloidoses and autoimmune neurological diseases,” published in Journal of Biological Physics and Chemistry in 2016.

Why is glyphosate, which causes or contributes to most-to-all diseases and disorders, including cancer and autism, in vaccines? Because (1) vaccines contain soy, sucrose, fructose, lactose, bovine serum, and egg protein derived from non-organic, glyphosate-contaminated sources; (2) vaccines contain gelatin derived from pigs and cows fed heavily glyphosate-contaminated soy, corn, and beet pulp; (3) viruses are grown on cultures containing glyphosate-contaminated sugar and other glyphosate-contaminated ingredients.


